**STATUTORY NOTICE AND DECLARATION
OF
NEW MEXICO SKIES HOMEOWNERS ASSOCIATION, INC.**

PURSUANT TO the New Mexico Homeowners Association Act, NMSA 1978 Comp., §§ 47-16-1 through 47-16-6, and specifically §47 -16-4 thereof:

1. The New Mexico Skies Homeowners Association, Inc., gives statutory notice and declares that it is a duly constituted homeowners association for and on behalf of the New Mexico Skies subdivision, a subdivision in Otero County, State of New Mexico, which subdivision is an astronomy conclave.
2. The New Mexico Skies Homeowners Association, Inc., was organized before July 1, 2013.
3. The name and address of the association is: New Mexico Skies Homeowners Association, Inc., P.O. Box 317, Mayhill, NM 88339.
4. The New Mexico Skies Homeowners Association, Inc., is a non-profit corporation organized pursuant to the laws of the State of New Mexico, and bears the New Mexico Public Regulation Commission number 4023776.
