

AMENDMENT TO RESTRICTIVE COVENANTS

The undersigned, being all the property owners of the Plainview Acres Subdivision in the City of Alamogordo, Otero County, New Mexico, hereby contract, agree and declare jointly and severally, with each other and among themselves that those certain restrictive covenants recorded at Book 241, Pages 468 - 469 of the Records of Otero County that are a part of and attached to all of the tract of land known as Plainview Acres Subdivision are hereby changed and amended except as to Lots 8 through 48, and Lot 111 and Lot 112 as follows:

Paragraph (a) is changed to read as follows:

All Lots in the tract shall be described as residential lots and to be used for residential purposes.

Paragraph (b) is omitted and not to have any further force and affect to the remaining undeveloped, as of March, 1969, land.

Paragraph (c) is omitted and not to have any further force and affect to the remaining undeveloped, as of March, 1969, land.

Paragraph (f) is changed to read as follows:

No dwelling shall be permitted in the tract having a ground floor area of less than 800 square feet, and no building or structure shall be of more than one story or level.

Paragraph (g) is changed to read as follows:

Multi-family, single-story dwelling units and appurtenant buildings shall be permitted throughout the remaining undeveloped as of March, 1969, land. It is understood and agreed that in the event the remaining undeveloped land is to be used for any sort of public housing development, that a community facility and office building may be erected within the tract.
