KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED, THE CLOUD-CROFT COMPANY, BEING THE OWNER AND PROPRIETOR OF A TRACT OF LAND COMPRISING A PART OF LOTS 14, 18, AND 19, SECTION 5, T16S, R12E, NMPM, AND MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:
