


REPLAT OF PORTIONS OF BLOCKS 32 & 34 OF HEIGHTS ADDITION UNITS A B C & D AS AMENDED

THE REPLAT, HEREBY SHOWN, OF PORTIONS OF BLOCKS 32 AND 34, OF HEIGHTS ADDITION UNITS A B C AND D AS AMENDED, OF THE CITY OF ALAMOGORDO, NEW MEXICO, AS SAID PORTIONS OF BLOCKS 32 AND 34 IS SHOWN AND DESIGNATED ON THE PLAT OF SAID HEIGHTS ADDITION UNITS A B C AND D AS AMENDED, FILED IN THE OFFICE OF THE COUNTY CLERK OF OTERO COUNTY, NEW MEXICO, ON THE 23rd DAY OF AUGUST, 1957, NOW REPLATED AND RESUBDIVIDED AS HEREBY SHOWN, BEING THE REPLAT OF PORTIONS OF BLOCKS 32 AND 34, COMPRISING OF NEW LOTS 19 THROUGH 34 INCLUSIVE, BLOCK 34 AND LOTS 1 THROUGH 13 INCLUSIVE, BLOCK 32, A PORTION OF ONE PUBLIC ALLEY AND A PORTION OF ONE PUBLIC STREET DESIGNATED AS CRESCENT DRIVE, ALL IN HEIGHTS ADDITION UNITS A B C AND D AS AMENDED, ALL AS HEREBY SET FORTH, IS WITH THE FREE CONSENT AND IN ACCORDANCE WITH THE DESIRE OF THE UNDESIGNED OWNER AND PROPRIETOR THEREOF, AND SAID OWNER DOES HEREBY VACATE SAID PORTIONS OF BLOCKS 32 AND 34, HEIGHTS ADDITION UNITS A B C AND D AS AMENDED, ALL AS HEREBY SET FORTH, AND WITH THE FREE CONSENT AND IN ACCORDANCE WITH THE DESIRE OF THE UNDESIGNED OWNER AND PROPRIETOR THEREOF, AND SAID OWNER DOES HEREBY DEDICATE SAID PUBLIC ALLEY AND PUBLIC STREET AS SHOWN ON THE REPLAT OF PORTIONS OF BLOCK 32 AND 34, HEIGHTS ADDITION UNITS A B C AND D AS AMENDED, TO PUBLIC USE.
