Kidd Jr. and Dorothy M. Kidd, his wife, Fred C. Silva and Dorothy Silva, his wife, Frank C. Rolland, a widower, Kenneth O. Shepperd and Virginia D. Shepperd, his wife, and Mrs. Edna Posey, being the owners and proprietors of a certain tract of land, described as follows, to wit: all of Block 109 of the Original Townsite of Alamogordo, Otero County, New Mexico, and desiring to further subdivide said tract of land into Lots, Streets, and Alleys, and with their free consent and in accordance with their said desire have caused the above map or plat to be made and filed in the office of the Clerk of the City of Alamogordo, New Mexico, and in the office of the Clerk and Recorder of the County of Otero, New Mexico. We do hereby dedicate said streets and alleys to the use of the public, and do further agree that garbage and trash cans shall be set back from the alleys and shall be so enclosed or fenced that they are not visible from the streets, and that any lots sold shall be subject to such restriction.
