KNOW ALL MEN BY THESE PRESENTS, THAT THE UNDERSIGNED H. N. BAXLEY AND ELIZABETH BAXLEY, HIS WIFE, AND CLINTON CHENOWETH AND MARGARET CHENOWETH, HIS WIFE, BEING THE OWNERS AND PROPRIETORS OF A CERTAIN TRACT OF LAND, DESCRIBED AS FOLLOWS, TO WIT:

THIS MAP OR PLAT OF THE RESUBDIVISION OF LOTS 1, 2, AND 3, BLOCK 217, TOWNSITE OF ALAMOGORDO, NEW MEXICO, WAS ON THIS 12<sup>th</sup> DAY OF November, 1954, SUBMITTED TO THE BOARD OF COMMISSIONERS OF THE CITY OF ALAMOGORDO, NEW MEXICO, AND WAS APPROVED BY THREE-FOURTHS OF THE MEMBERS ELECTED THERETO.

ALL OF LOTS 1, 2, AND 3, OF BLOCK 217, TOWNSITE OF ALAMOGORDO, OTERO COUNTY, NEW MEXICO, AND DESIRING TO RESUBDIVIDE SAID TRACT OF LAND INTO LOTS AND ALLEYS, AND WITH THEIR FREE CONSENT AND IN ACCORDANCE WITH THEIR SAID DESIRE HAVE CAUSED THE ABOVE MAP OR PLAT OF THE RESUBDIVISION TO BE MADE AND FILED IN THE OFFICE OF THE CLERK OF THE CITY OF ALAMOGORDO, NEW MEXICO, AND IN THE OFFICE OF THE CLERK AND EX-OFFICIO RECORDER OF THE COUNTY OF OTERO, NEW MEXICO. WE DO HEREBY DEDICATE SAID ALLEYS TO THE USE OF THE PUBLIC, AND DO FURTHER AGREE THAT ALL GARBAGE AND TRASH CONTAINERS SHALL BE SET BACK FROM THE ALLEYS AND SHALL BE SO ENCLOSED OR FENCED THAT THEY SHALL NOT BE VISIBLE FROM THE STREETS, AND THAT ANY LOTS SOLD SHALL BE SUBJECT TO SUCH RESTRICTION.
