WE DO HEREBY DEDICATE SAID STREETS AND ALLEYS TO THE USE OF THE PUBLIC, AND DO FURTHER AGREE THAT ALL GARBAGE AND TRASH CONTAINERS SHALL BE SET BACK FROM THE ALLEYS AND SHALL BE SO ENCLOSED OR FENCED THAT THEY SHALL NOT BE VISIBLE FROM THE STREETS, AND THAT ANY LOTS SOLD SHALL BE SUBJECT TO SUCH RESTRICTION.
