

KNOW ALL MEN BY THESE PRESENTS THAT WE THE UNDERSIGNED, H. M. HERRERA AND HERRERA, HIS WIFE, BEING THE OWNERS OF A CERTAIN TRACT OF LAND KNOWN AS THE EAST HALF OF HOITALIZA 22, IN SECTION 30, T14S, R10E, NMPM, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

STARTING AT THE SECTION CORNER COMMON TO SECTIONS 30, 29, 19, AND 20, T14S, R10E, NMPM, AND GOING S 0° 16' W A DISTANCE OF 258.96 FEET; THENCE N 84° 55' W A DISTANCE OF 238.08 FEET; THENCE S 71° 35' W A DISTANCE OF 414.02 FEET; THENCE S 20° 55' E A DISTANCE OF 19.64 FEET TO THE PLACE OF BEGINNING; THENCE CONTINUING S 20° 55' E A DISTANCE OF 274.83 FEET; THENCE S 65° 48' W A DISTANCE OF 138.90 FEET; THENCE N 20° 59' W A DISTANCE OF 286.18 FEET; THENCE N 70° 27' 37" E A DISTANCE OF 140.09 FEET TO THE PLACE OF BEGINNING.
