

DANLEY, HIS WIFE, BEING THE OWNERS AND PROPRIETORS OF A CERTAIN TRACT OF LAND SITUATE IN THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 19, T 14 S, R 10 E, NMPM, OTERO COUNTY, NEW MEXICO, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO WIT:

BEGINNING AT A POINT ON THE EAST RIGHT OF WAY LINE OF U. S. HIGHWAY 54, SAID POINT BEARING S 89° 07' E 1080.80 FEET FROM THE QUARTER CORNER ON THE WEST LINE OF SECTION 19, T 14 S, R 10 E, NMPM; THENCE ALONG SAID HIGHWAY RIGHT OF WAY N 26° 48' W 50.42 FEET; THENCE S 89° 07' E 317.83 FEET; THENCE N 0° 59' E 509.21 FEET; THENCE S 76° 24' E 287.93 FEET; THENCE S 77° 57' E 719.73 FEET; THENCE S 9° 42' 20" E 207.84 FEET; THENCE N 89° 11' 40" E 277.96 FEET; THENCE S 0° 32' W 147.20 FEET; THENCE S 89° 35' 40" W 1303.73 FEET; THENCE N 89° 07' W 239.30 FEET TO THE POINT OF BEGINNING.




