Hendricks HIS WIFE, HEREBY CERTIFY THAT THE SUBDIVISION OF THE TRACT OF LAND SHOWN ON THIS MAP, AND HEREIN - AFTER DESCRIBED, SITUATED IN THE COUNTY AND STATE AFORESAID, IS WITH THE FREE CONSENT AND IN ACCORDANCE WITH THE DESIRES OF THE UNDERSIGNED OWNERS, AND THE SAID OWNERS DEDICATE TO THE USE OF THE PUBLIC THE STREET AS SHOWN HEREON; THE TRACT OF LAND REFERRED TO BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO WIT:
