FROM A BRASS CAP WHICH MARKS THE QUARTER SECTION CORNER ON THE WEST LINE OF SEC. 6, T. 16 S., R. 12 E., N.M.P.M., WHICH POINT IS ALSO THE SOUTHWEST CORNER OF LOT 28 OF SAID SEC. 6; THENCE NORTH 0° 30' EAST ALONG THE WEST LINE OF SAID LOT 21 A DISTANCE OF 18 FEET TO THE POINT OF BEGINNING OF THIS TRACT; THENCE NORTH 83° 01' EAST 415 FEET TO A POINT; THENCE NORTH 39° 01' EAST 573 FEET TO A POINT; THENCE NORTH 67° 01' EAST 452.9 FEET TO A POINT; THENCE NORTH 41° 30' EAST 547.3 FEET TO A POINT; THENCE NORTH 62° 01' EAST 300 FEET TO A POINT; THENCE NORTH 53° 30' EAST 97 FEET TO A POINT; THENCE SOUTH 0° 10' WEST 45 FEET TO A POINT; THENCE SOUTH 89° 25' EAST 385 FEET TO A POINT; THENCE SOUTH 0° 10' WEST 200 FEET TO A POINT; THENCE SOUTH 89° 25' EAST 165 FEET MORE OR LESS, TO A POINT ON THE EAST LINE OF LOT 22 OF SAID SEC. 6; THENCE SOUTH 0° 10' WEST ALONG SAID EAST LINE OF SAID LOT 22 A DISTANCE OF 921.5 FEET TO A POINT ON SAID LINE, WHICH POINT IS THE SOUTHEAST CORNER OF LOT 22 OF SEC. 6; THENCE NORTH 89° 25' WEST 2584.0 FEET TO QUARTER SECTION CORNER ON WEST LINE OF SEC. 6; THENCE NORTH 0° 30' EAST 18 FEET TO PLACE OF BEGINNING;
