KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED, BEING THE SOLE OWNERS AND PROPRIETORS OF A CERTAIN TRACT OF LAND LYING WITHIN "LOST LODGE SUBDIVISION, UNIT NO. 1" ACCORDING TO THE OFFICIAL MAP OF SAID SUBDIVISION, FILED IN THE OFFICE OF THE COUNTY CLERK OF OTERO COUNTY, NEW MEXICO, ON DECEMBER 4, 1954, SAID TRACT NOT BEING PLATTED IN LOTS AND BLOCKS IN SAID SUBDIVISION, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

TRACT NO. 1

FROM A ROCK CORNER MARKER WHICH MARKS THE SOUTHWEST CORNER OF SUBDIVISION LOT 19, SECTION 6, T. 16 S., R. 12 E., N.M.P.M., WHICH POINT IS ALSO THE SOUTHWEST CORNER OF LOT 19 OF SAID SECTION 6; THENCE NORTH 0° 9' EAST ALONG THE WEST LINE OF SAID LOT 19 A DISTANCE OF 325 FEET TO THE POINT OF BEGINNING OF THIS TRACT; THENCE SOUTH 89° 25' E, ALONG THE NORTH LINE OF LOTS 16 & 15, BLOCK 4, "LOST LODGE UNIT NO. 1" A DISTANCE OF 382.3 FEET TO A POINT; THENCE NORTH 73° 10' EAST A DISTANCE OF 246.7 FEET TO A POINT, WHICH POINT IS ALSO THE NORTHEAST CORNER OF LOT 13, BLOCK 4, "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE NORTH 45° 0' EAST A DISTANCE OF 310 FEET TO A POINT, WHICH POINT IS THE SOUTHWEST CORNER OF LOT 9, BLOCK 4, "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE NORTH 38° 0' WEST A DISTANCE OF 238 FEET TO A POINT, WHICH POINT IS THE SOUTHWEST CORNER OF LOT 8, BLOCK 4, "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE NORTH 21° 30' WEST A DISTANCE OF 563.9 FEET TO A POINT ON THE NORTH SUBDIVISION LINE OF LOT 19, SECTION 6, T. 16 S., R. 12 E., N.M.P.M., WHICH POINT IS THE NORTHWEST CORNER OF LOT 6, BLOCK 4, "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE NORTH 89° 25' WEST ALONG SAID SUBDIVISION LINE A DISTANCE OF 503.6 FEET TO A POINT, WHICH POINT IS THE NORTHWEST CORNER OF SUBDIVISION LOT 19, SECTION 6, T. 16 S., R. 12 E.; THENCE SOUTH 0° 9' WEST A DISTANCE OF 994 FEET TO THE PLACE OF BEGINNING.

BEGINNING POINT OF THIS TRACT IS THE NORTHEAST CORNER OF LOT 19, SEC. 6, T. 16 S., R. 12 E., N.M.P.M.; THENCE NORTH 89° 25' WEST ALONG THE NORTH SUBDIVISION LINE A DISTANCE OF 180 FEET TO A POINT, WHICH POINT IS THE NORTHEAST CORNER OF LOT 1, BLOCK 5 OF "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE SOUTH 5° 0' EAST A DISTANCE OF 327 FEET TO A POINT, WHICH POINT IS THE SOUTHEAST CORNER OF LOT 2, BLOCK 5, "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE NORTH 89° 25' WEST A DISTANCE OF 200 FEET TO A POINT, WHICH POINT IS THE SOUTHWEST CORNER OF LOT 2, BLOCK 5, "LOST LODGE SUBDIVISION, UNIT NO. 1"; THENCE SOUTH 1° 30' WEST A DISTANCE OF 83 FEET TO A POINT; THENCE SOUTH 14° 0' EAST A DISTANCE OF 105 FEET TO A POINT; THENCE SOUTH 34° 30' EAST A DISTANCE OF 392 FEET TO A POINT; THENCE SOUTH 89° 25' EAST A DISTANCE OF 100 FEET TO A POINT, ON THE EAST LINE OF SUBDIVISION LOT 19, SEC. 6, T. 16 S., R. 12 E.; THENCE NORTH 0° 10' EAST A DISTANCE OF 840.3 FEET TO THE PLACE OF BEGINNING; AND DESIRING TO RESUBDIVIDE SAID TRACTS INTO LOTS AND BLOCKS, STREETS AND ALLEYS, AND WITH THEIR FREE CONSENT, AND IN ACCORDANCE WITH THEIR DESIRES, HAVE CAUSED THE FOREGOING MAP OF "LOST LODGE SUBDIVISION, UNIT NO. 1" TO BE MADE AND FILED IN THE OFFICE OF THE COUNTY CLERK AND EX-OFFICIO RECORDER OF OTERO COUNTY, NEW MEXICO, AND DO HEREBY DEDICATE THE SAID STREETS AND ALLEYS TO THE USE OF THE PUBLIC.
