


QUARTER SECTION CORNER

KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED, THE CLOUDCROFT CO. BEING THE OWNER AND PROPRIETOR OF LOT 29, SECTION 5, TOWNSHIP 16 SOUTH, RANGE 12 EAST, NMPM, AND SAID LOT 29 IS MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGIN AT THE NORTH QUARTER SECTION CORNER OF SAID SECTION 5; THENCE N 89° 51' E A DISTANCE OF 651.06 FEET; THENCE S 0° 21' W A DISTANCE OF 450.53 FEET; THENCE S 89° 52' W A DISTANCE OF 650.10 FEET; THENCE N 0° 13' E A DISTANCE OF 450.85 FEET TO THE POINT OF BEGINNING AND CONTAINING 6.73 ACRES MORE OR LESS.

AND DESIRING TO SUBDIVIDE SAID TRACT OF LAND INTO LOTS, BLOCKS AND STREETS, AND WITH OUR FREE CONSENT AND IN ACCORDANCE WITH OUR SAID DESIRE HAVE CAUSED SAID TRACT OF LAND TO BE PLATTED INTO A SUBDIVISION KNOWN AS "ADDITION NO. 5 TO CLOUDCROFT" AS SHOWN ON THE FOREGOING PLAT, AND IN FILING SAID PLAT DO HEREBY DEDICATE TO THE USE OF THE PUBLIC, THE STREETS AND EASEMENTS AS SHOWN THEREON, AND RESERVING TO THE VILLAGE OF CLOUDCROFT AN EASEMENT AND RIGHT-OF-WAY TO LAY AND INSTALL UTILITY LINES OVER, ABOVE AND BELOW THE SURFACE OF THIS PROPERTY.
