


KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED, THE CLOUDCROFT CO. BEING THE OWNER AND PROPRIETOR OF LOT 32 OF THE RESUBDIVISION OF LOT 9, SECTION 5, TOWNSHIP 16 SOUTH, RANGE 12 EAST, NMPM, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

STARTING AT THE NORTH QUARTER SECTION CORNER OF SECTION 5, T16S, R12E, NMPM, AND GOING N 89° 51' E ALONG THE NORTH LINE OF SAID SECTION 5 A DISTANCE OF 1302.12 FEET; THENCE S 0° 18' W A DISTANCE OF 2471.1 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE S 89° 30' E A DISTANCE OF 644.67 FEET; THENCE S 0° 29' W A DISTANCE OF 338.38 FEET; THENCE N 89° 26' W A DISTANCE OF 643.87 FEET; THENCE N 0° 18' E A DISTANCE OF 337.75 FEET TO THE PLACE OF BEGINNING AND CONTAINING 5 ACRES MORE OR LESS.
