

KNOW ALL MEN BY THESE PRESENTS THAT THE UNDERSIGNED, JESSE L. HUDMAN AND CLOTHA HUDMAN, HIS WIFE, BEING THE OWNERS OF A CERTAIN TRACT OF LAND IN THE SE $\frac{1}{4}$ SE $\frac{1}{4}$ OF SECTION 7, T16S, R10E, NMPM, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

STARTING AT THE SECTION CORNER COMMON TO SECTIONS 7, 8, 17, AND 18, T16S, R10E AND GOING N. 0° 03' W ALONG THE EAST LINE OF SAID SECTION 7 A DISTANCE OF 50.0 FEET; THENCE N 89° 49' W A DISTANCE OF 148.7 FEET; THENCE S 0° 03' E A DISTANCE OF 50 FEET TO THE NORTH RIGHT-OF-WAY LINE OF 24th STREET; THENCE N 89° 49' W ALONG THE SAID RIGHT-OF-WAY LINE A DISTANCE OF 60.0 FEET; THENCE N 0° 03' W A DISTANCE OF 208.7 FEET; THENCE S 89° 49' E A DISTANCE OF 208.7 FEET TO THE EAST LINE OF SAID SECTION 7; THENCE S 0° 03' E ALONG THE EAST LINE OF SAID SECTION 7 A DISTANCE OF 158.7 FEET TO THE PLACE OF BEGINNING AND CONTAINING 0.83 ACRES MORE OR LESS.

SAID OWNERS DO HEREBY IN ACCORDANCE WITH THEIR FREE WILL AND DESIRE, CAUSE SAID TRACT OF LAND TO BE SUBDIVIDED AND PLATTED INTO A SUBDIVISION KNOWN AS "HUDMAN TRACTS" AS SHOWN ON THE FOREGOING PLAT. WE HEREBY DEDICATE TO PUBLIC USE THAT PART OF FLORIDA AVENUE AS SHOWN HERON.
