**DEDICATION:**

THE FOREGOING SUBDIVISION OF THAT CERTAIN TRACT OF LAND SITUATE IN SECTION 21 TOWNSHIP 16 SOUTH; RANGE 10 EAST; N.M.P.M., CITY OF ALAMOGORDO, OTERO COUNTY, NEW MEXICO BEING AND COMPRISING THE WESTERLY 23.1230 ACRES OF THE SOUTHEAST QUARTER (SE/4) OF THE SOUTHWEST QUARTER (SW/4) OF THE SAID SECTION 21 AND HEREIN MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER NO. 1 OF THE TRACT HEREIN SET FORTH, SAID CORNER NO. 1 BEING A POINT ON THE SOUTHERLY LINE OF THE SAID SECTION 21 FROM WHICH THE SOUTHWEST CORNER OF THE SAID SECTION 21 BEARS N. 89° 58' W. 1326.30 FEET AND RUNNING THENCE DUE NORTH 1331.05 FEET TO THE NORTHWEST CORNER NO. 2 OF THE TRACT HEREIN SET FORTH; SAID CORNER NO. 2 BEING THE IDENTICAL SOUTHWEST CORNER OF DALE BELLAMAH ADDITION UNIT NO. 3 IN THE CITY OF ALAMOGORDO, NEW MEXICO AS THE SAME WAS FILED IN THE OFFICE OF THE COUNTY CLERK OF OTERO COUNTY, NEW MEXICO ON THE 22ND DAY OF MAY 1959; THENCE ALONG THE SOUTHERLY LINE OF THE SAID DALE BELLAMAH ADDITION UNIT NO. 3 S. 89° 41' E. 757.80 FEET TO THE NORTHEAST CORNER NO. 3 OF THE TRACT HEREIN SET FORTH; THENCE DUE SOUTH 1327.30 FEET TO THE SOUTHEAST CORNER NO. 4 OF THE TRACT HEREIN SET FORTH; SAID CORNER NO. 4 BEING A POINT ON THE SOUTHERLY LINE OF THE SAID SECTION 21; THENCE N. 89° 58' W. 757.79 FEET TO THE SOUTHWEST CORNER NO. 1 AND THE POINT OF BEGINNING.
