


SCENIC ADDITION ALAMOGORDO, OTERO COUNTY, NEW MEXICO

KNOW ALL MEN BY THESE PRESENTS THAT THE FOLLOWING DESCRIBED TRACT OF LAND IS OWNED BY THE CITY OF ALAMOGORDO, NEW MEXICO, AND IS LOCATED IN THE N½ N½ OF SECTION 21, T16S, R10E, NMPM, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF LOT 8, BLOCK 17, OF DALE BELLAMAH ADDITION UNIT NO. 4-A, CITY OF ALAMOGORDO, NEW MEXICO, RECORDED IN THE OFFICE OF THE COUNTY CLERK OF OTERO COUNTY, NEW MEXICO, DECEMBER 13, 1965, BOOK 11, PAGE 3, FILE NO. 53500, AND GOING N 59° 27' E A DISTANCE OF 146.71 FEET: THENCE ALONG A CURVE TO THE LEFT WITH A RADIUS OF 425.22 FEET THROUGH AN ARC OF 59° 27' AN ARC DISTANCE OF 441.21 FEET: THENCE NORTH A DISTANCE OF 49.63 FEET: THENCE N 52° 40' W A DISTANCE OF 56.60 FEET: THENCE N 89° 09' E A DISTANCE OF 70.0 FEET: THENCE SOUTH A DISTANCE OF 20.0 FEET: THENCE N 89° 09' E A DISTANCE OF 75.0 FEET TO THE WEST RIGHT-OF-WAY LINE OF SCENIC DRIVE: THENCE SOUTH ALONG THE WEST LINE OF SCENIC DRIVE A DISTANCE OF 66.11 FEET: THENCE CONTINUING ALONG THE WEST LINE OF SCENIC DRIVE ALONG A CURVE TO THE RIGHT WITH A RADIUS OF 525.22 FEET THROUGH AN ARC OF 59° 27' AN ARC DISTANCE OF 544.97 FEET: THENCE S 59° 27' W A DISTANCE OF 146.71 FEET TO THE SOUTHEAST CORNER OF SAID LOT 8, BLOCK 17: THENCE N 30° 33' W A DISTANCE OF 100 FEET TO THE PLACE OF BEGINNING AND CONTAINING 1.65 ACRES MORE OR LESS,

SAID OWNERS DO HEREBY IN ACCORDANCE WITH THEIR FREE WILL AND DESIRE, CAUSE SAID TRACT OF LAND TO BE SUBDIVIDED AND PLATTED INTO A SUBDIVISION KNOWN AS "SCENIC ADDITION" AS SHOWN ON THE FOREGOING PLAT, AND IN RECORDING THIS PLAT DO HEREBY DEDICATE TO THE USE OF THE PUBLIC THE STREET, ALLEYS, AND EASEMENTS AS SHOWN HEREON.
