


BEGINNING AT THE SECTION CORNER COMMON TO SECTIONS 7, 8, 17, AND 18, T16S, R10E, NMPM, AND GOING N 89° 49' W ALONG THE SOUTH LINE OF SAID SECTION 7 A DISTANCE OF 208.7 FEET TO THE PLACE OF BEGINNING; THENCE CONTINUING N 89° 49' W ALONG THE SOUTH LINE OF SAID SECTION 7 A DISTANCE OF 834.82 FEET; THENCE N 0° 03' E A DISTANCE OF 208.7 FEET; THENCE S 89° 49' E A DISTANCE OF 834.82 FEET; THENCE S 0° 03' W A DISTANCE OF 208.7 FEET TO THE PLACE OF BEGINNING AND CONTAINING 4.0 ACRES
