

KNOW ALL MEN BY THESE PRESENTS THAT SHELBY F. MILLER AND CLARE D. MILLER, HIS WIFE, ARE THE OWNERS AND PROPRIETORS OF THE FOLLOWING TRACT OF LAND LOCATED IN THE NE 1/4 AND IN LOTS 1 & 2, SECTION 7, T16S, R10E, NMPM, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

STARTING AT THE NORTH ONE QUARTER CORNER OF SAID SECTION 7 AND GOING N 89° 06' 20" W ALONG THE NORTH LINE OF SAID SECTION 7 A DISTANCE OF 340.58 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE S 18° 49' 30" E A DISTANCE OF 1878.53 FEET; THENCE S 89° 57' 00" W A DISTANCE OF 335.12 FEET TO THE EAST RIGHT-OF-WAY LINE OF U.S. HIGHWAY 54-70, NEW MEXICO PROJECT NO. P-020-1(1); THENCE N 18° 49' 30" W ALONG SAID RIGHT-OF-WAY LINE A DISTANCE OF 1825.98 FEET; THENCE N 00° 25' 20" W A DISTANCE OF 55.35 FEET TO THE NORTH LINE OF SAID SECTION 7; THENCE S 89° 06' 20" E ALONG THE NORTH LINE OF SAID SECTION 7 A DISTANCE OF 339.62 FEET TO THE SAID PLACE OF BEGINNING, AND CONTAINING 14.553 ACRES, MORE OR LESS.
