

STARTING AT THE SECTION CORNER COMMON TO SECTIONS 28, 29, 32 & 33, T16S, R10E, NMPM, AND GOING N 00° 02' W A DISTANCE OF 30 FEET; THENCE N 89° 07' W A DISTANCE OF 703.63 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE CONTINUING N 89° 07' W A DISTANCE OF 175.02 FEET; THENCE N 00° 02' W A DISTANCE OF 504.38 FEET; THENCE N 89° 58' E A DISTANCE OF 175.00 FEET; THENCE S 00° 02' E A DISTANCE OF 509.18 FEET TO THE SAID PLACE OF BEGINNING, AND CONTAINING 2.040 ACRES, MORE OR LESS.
