



BEGINNING AT THE NORTHWEST CORNER OF SAID BLOCK 44 AND GOING N 89° 32' E ALONG THE SOUTH RIGHT-OF-WAY LINE OF POST AVENUE A DISTANCE OF 600.0 FEET; THENCE S 0° 28' E ALONG THE WEST RIGHT-OF-WAY LINE OF BIGGS AVENUE A DISTANCE OF 600.0 FEET; THENCE S 89° 32' W ALONG THE NORTH RIGHT-OF-WAY LINE OF WRIGHT AVENUE A DISTANCE OF 600.0 FEET; THENCE N 0° 28' W ALONG THE EAST RIGHT-OF-WAY LINE OF TRAVIS AVENUE A DISTANCE OF 600.0 FEET TO THE PLACE OF BEGINNING AND CONTAINING 8.264 ACRES.
