




DESCRIPTION

KNOW ALL MEN BY THESE PRESENTS THAT PNP, INC. IS THE OWNER AND PROPRIETOR OF BLOCK 15, AIRPORT BLOCKS, ALAMOGORDO, OTERO COUNTY, NEW MEXICO, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:
