



REPLAT A BLOCK 15

DESCRIPTION

KNOW ALL MEN BY THESE PRESENTS THAT GEORGE J. CORBETT AND GUS CORBETT, TRUSTEES FOR GEORGE J. CORBETT AND GUS CORBETT ARE THE OWNERS AND PROPRIETORS OF LOT 3 AND THE SOUTH 10.5 FEET OF LOT 4, BLOCK 15, ALAMOGORDO, OTERO COUNTY, NEW MEXICO, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

STARTING AT THE SOUTHWEST CORNER OF SAID BLOCK 15 AND GOING NORTH ALONG THE WEST LINE OF SAID BLOCK 15 A DISTANCE OF 50.00 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE CONTINUING NORTH A DISTANCE OF 35.50 FEET; THENCE EAST A DISTANCE OF 120.00 FEET; THENCE SOUTH A DISTANCE OF 35.50 FEET; THENCE WEST A DISTANCE OF 120.00 FEET TO THE SAID PLACE OF BEGINNING, AND CONTAINING 0.098 ACRES, MORE OR LESS.
