



KNOW ALL MEN BY THESE PRESENTS THAT BETHEL BAPTIST CHURCH, INC. IS THE OWNER AND PROPRIETOR OF A TRACT OF LAND IN THE NW1/4 NE1/4 OF SECTION 21, T16S, R10E, NMPM, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:
