


KNOW ALL MEN BY THESE PRESENTS THAT THE COUNTY OF OTERO, STATE OF NEW MEXICO, ACTING THROUGH ITS BOARD OF COUNTY COMMISSIONERS, IS THE OWNER AND PROPRIETOR OF BLOCK 138, TOWN OF ALAMOGORDO, NEW MEXICO, DESCRIBED BY METES AND BOUNDS AS FOLLOWS: BEGINNING AT THE SOUTHWEST CORNER OF SAID BLOCK 138 AND GOING NORTH ALONG THE EAST RIGHT-OF-WAY LINE OF FILIPINO AVENUE A DISTANCE OF 300 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF TENTH STREET; THENCE EAST ALONG THE SOUTH RIGHT-OF-WAY LINE OF TENTH STREET A DISTANCE OF 316 FEET TO THE WEST RIGHT-OF-WAY LINE OF CUBA AVENUE; THENCE SOUTH ALONG THE WEST RIGHT-OF-WAY LINE OF CUBA AVENUE A DISTANCE OF 300 FEET TO THE NORTH RIGHT-OF-WAY LINE OF NINTH STREET; THENCE WEST ALONG THE NORTH RIGHT-OF-WAY LINE OF NINTH STREET A DISTANCE OF 316 FEET TO THE SAID PLACE OF BEGINNING, AND CONTAINING 2.176 ACRES, MORE OR LESS.
