



KNOW ALL MEN BY THESE PRESENTS THAT VETERANS OF FOREIGN WARS, POST 7686 IS THE OWNER AND PROPRIETOR OF A TRACT OF LAND IN LOTS 7 THROUGH 12, BLOCK 1, A.G. MCMATH BUILDING SITE, 1 AND 3 REVISED, ALAMOGORDO, OTERO COUNTY, NEW MEXICO. DESCRIBED BY METES AND BOUNDS AS FOLLOWS:
