

KNOW ALL MEN BY THESE PRESENTS THAT THE CITY OF ALAMOGORDO IS THE OWNER AND PROPRIETOR OF A TRACT OF LAND IN THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 29, TOWNSHIP 16 SOUTH, RANGE 10 EAST, N.M.P.M., BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

STARTING AT THE NORTH ONE-QUARTER CORNER OF SAID SECTION 29 AND GOING N 89°53' W ALONG THE NORTH LINE OF SAID SECTION 29 A DISTANCE OF 187.50 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE S 00°02' E A DISTANCE OF 693.72 FEET; THENCE N 89°53' W A DISTANCE OF 127.50 FEET; THENCE N 00°02' W A DISTANCE OF 543.72 FEET; THENCE S 89°53' E A DISTANCE OF 127.50 FEET; THENCE N 00°02' W A DISTANCE OF 150.00 FEET; THENCE S 89°53' E A DISTANCE OF 30.00 FEET TO THE PLACE OF BEGINNING.
