


BEGINNING AT THE SOUTHWEST CORNER OF SAID LOT 1 AND GOING N89°08'11"E ALONG THE WEST LINE OF SAID LOT 1 A DISTANCE OF 184.29 FEET; THENCE S89°37'00"E A DISTANCE OF 25.00 FEET; THENCE ALONG THE ARC OF A CURVE TO THE LEFT WHOSE CENTRAL ANGLE IS 34°58'52" AND WHOSE RADIUS IS 123.13 FEET AN ARC DISTANCE OF 75.10 FEET; THENCE ALONG THE ARC OF A CURVE TO THE RIGHT WHOSE CENTRAL ANGLE IS 78°03'19" AND WHOSE RADIUS IS 29.00 FEET AN ARC DISTANCE OF 28.55 FEET; THENCE S15°07'40"E A DISTANCE OF 125.88 FEET; THENCE N74°52'20"E A DISTANCE OF 182.00 FEET; THENCE S52°02'49"E A DISTANCE OF 287.67 FEET; THENCE N88°31'08"W A DISTANCE OF 153.10 FEET; THENCE S77°58'09"W A DISTANCE OF 175.00 FEET; THENCE S85°48'31"W A DISTANCE OF 38.00 FEET; THENCE S89°08'30"W A DISTANCE OF 182.00 FEET; THENCE N67°11'39"W A DISTANCE OF 394.57 FEET; THENCE N54°04'21"E A DISTANCE OF 192.78 FEET; THENCE S65°28'40"E A DISTANCE OF 156.88 FEET TO THE SAID PLACE OF BEGINNING, AND CONTAINING 2.654 ACRES, MORE OR LESS.


