


# SUMMARY PLAT REPLAT B, BLOCK 230

BEGINNING AT THE NORTHEAST CORNER OF SAID BLOCK 230 AND GOING SOUTH ALONG THE EAST LINE OF SAID BLOCK 230 A DISTANCE OF 390.00 FEET; THENCE WEST ALONG THE SOUTH LINE OF LOT 1, RESUBDIVISION OF LOT 4, BLOCK 230 AS FILED FOR RECORD IN THE OFFICE OF THE OTERO COUNTY CLERK AND EX-OFFICIO RECORDER ON THE 15th DAY OF OCTOBER, 1956 A DISTANCE OF 108.12 FEET; THENCE NORTH ALONG THE EAST LINE OF A TWENTY FOOT WIDE ALLEY A DISTANCE OF 390.00 FEET TO THE NORTH LINE OF SAID BLOCK 230; THENCE EAST ALONG SAID NORTH LINE A DISTANCE OF 108.12 FEET TO THE PLACE OF BEGINNING AND CONTAINING 0.9680 ACRES, MORE OR LESS.


