



KNOW ALL MEN BY THESE PRESENTS THAT TIERRA DE Suenos, INC., A NEW MEXICO CORPORATION, IS THE OWNER AND PROPRIETOR OF TRACT C AND TRACT D, REPLAT A, LOT 3, BLOCK 14, DALE BELLAHMAH ADDITION, UNIT NO. 4-C, AND A PORTION OF THE TENTH STREET RIGHT-OF-WAY, ALAMOGORDO, OTERO COUNTY, NEW MEXICO, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:
