





KNOW ALL MEN BY THESE PRESENTS, THAT THE CITY OF ALAMOGORDO, OTERO COUNTY, NEW MEXICO, A MUNICIPAL CORPORATION, IS THE OWNER OF A CERTAIN TRACT OF LAND SITUATE IN THE NORTHEAST QUARTER OF SECTION 29, T16S, R10E, MPM, KNOWN AS ALAMO CEMETERY, AND SHOWN ON THE PLAT OF ALAMO CEMETERY, FILED FOR RECORD IN THE OFFICE OF THE CLERK OF OTERO COUNTY, NEW MEXICO, ON THE 30TH DAY OF APRIL 1900, AND THAT THE CITY OF ALAMOGORDO DOES DESIRE TO RESUBDIVIDE BLOCK 5, DIVISION A, AS SHOWN ON SAID PLAT OF ALAMO CEMETERY, EXCEPT THAT PART OF SAID BLOCK 5, DIVISION A, THAT HAS BEEN RESUBDIVIDED AS SHOWN ON THAT CERTAIN PLAT ENTITLED "MONTE VISTA CEMETERY", FILED FOR RECORD IN THE OFFICE OF THE CLERK OF OTERO COUNTY, NEW MEXICO, ON THE 17TH DAY OF AUGUST, 1954, AND ALL OF BLOCKS 10 AND 11, DIVISION A, AS SHOWN ON SAID ALAMO CEMETERY MAP, AND THE CITY OF ALAMOGORDO DOES FURTHER DESIRE TO VACATE THAT CERTAIN PLAT FILED FOR RECORD IN THE OFFICE OF THE CLERK OF OTERO COUNTY, NEW MEXICO, ON THE 17TH DAY OF MAY, 1952, WHICH RESUBDIVIDES BLOCKS 1, 4, 5, 10, 11, 12, 13, 20, 21, 22, 23, 24, AND 25, OF THE ORIGINAL MAP OF THE ALAMO CEMETERY, FILED FOR RECORD IN THE OFFICE OF THE CLERK OF OTERO COUNTY, NEW MEXICO, ON THE 30TH DAY OF APRIL, 1900, EXCEPTING, HOWEVER, FROM SUCH VACATION, LOTS 1 AND 5 AND 6, BLOCK 10, AS SHOWN ON SAID PLAT.

THE CITY OF ALAMOGORDO, BY FILING THIS PLAT OF BLOCK "F", MONTE VISTA CEMETERY, DOES FURTHER COVENANT AND AGREE THAT THE ENTIRE TRACT REPRESENTED ON SAID PLAT SHALL REMAIN AND CONTINUE TO BE A CEMETERY, AND PLACE OF BURIAL FOR THE DEAD AND SHALL CONTINUE TO BE SUBJECT TO THE COVENANTS AND RESTRICTIONS SET FORTH ON SAID "MAP OF ALAMO CEMETERY", FILED FOR RECORD ON APRIL 30, 1900.

SAID OWNER DOES HEREBY DEDICATE THE STREETS TO THE USE OF THE PUBLIC.
