KNOW ALL MEN BY THESE PRESENTS, that the City of Alamogordo, Otero County, New Mexico, a Municipal Corporation, being the owner and proprietor of a certain tract of land situate in the Northwest quarter of Section 29, T 16 S, R 10 E, NMPM, being Blocks 1, 4 and 5 of the Alamogordo Cemetery as shown on that plat prepared by United Engineering Company, November 1951, and filed in the office of the County Clerk and Recorder of Otero County, New Mexico, on the 17th day of May, 1952, and desiring to resubdivide said tract of land, has caused the foregoing map or plat to be prepared and filed.

This map or plat and the property herein described shall be subject to the same restrictions and reservations as set out in the dedication certificate of the original map of Alamo Cemetery, Otero County, New Mexico, on the 30th day of April, A.D., 1900.



