DESCRIPTION

A TRACT OF LAND BEING AND COMPRISING THE EAST HALF OF THE SOUTHEAST QUARTER (E 1/2 SE 1/4) OF SECTION 12, T.17S., R.14E., N.M.P.M., AND LOTS 3 AND 4 OF SECTION 7, T.17S., R.15E., N.M.P.M., AND BEING MORE PARTICULARLY DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING at the Section corner common to Section 12 and 13, T.17S., R.14E., N.M.P.M. and Sections 7 and 18, T.17S., R.15E., N.M.P.M., Thence N 87° 22' W a distance of 1410.09 feet; Thence N 00° 29' E a distance of 2644.64 feet; Thence S 89° 13' E a distance of 1375.44 feet to the East One-Quarter Corner of said Section 12; Thence S 00° 14' E a distance of 24.62 feet to the West One-Quarter corner of said Section 7; Thence N 89° 04' E a distance of 1160.67 feet; Thence S 00° 39' E a distance of 2650.12 feet; Thence S 88° 18' W a distance of 1180.00 feet to the point of beginning and containing 156.662 acres, more or less.
