


SMALL TRACTS ACT SURVEY NEW MEXICO NO. 120

CERTIFICATION:

This plat represents a record of the survey and monumentation of SMALL TRACTS ACT SURVEY N.M. No. 120, located in the SW1/4SE1/4 of Section 2, and in the NE1/4NE1/4 of Section 11, in T. 18 S., R. 12 E., NMPM, Otero County, New Mexico, within the Lincoln National Forest.

The original subdivision of T. 18 S., R. 12 E. was executed by William H. Herrick, Deputy Surveyor of the U.S. General Land Office in 1905. A Dependent Resurvey was made in 1940 by Wendell G. Hall of the U.S.G.L.O. These surveys are a record of the Bureau of Land Management in Santa Fe. Section 11 was resurveyed and subdivided by Wilfried E. Roeder, Land Surveyor of the U.S. Forest Service (NM Registration No. 4691) in 1986 and recorded in the Otero County records on 2-25-1987. The National Forest boundary was posted in 1986 and disclosed an encroachment onto National Forest System land. The adjoining land owner applied for title to the encroached lands under Public Law 97-465 (Small Tracts Act).

Bearings shown on this plat are based the official 1940 GLO record for the east 1/2 of the north boundary of Section 11.

I certify that this survey and monumentation was made by me or my assistants under my supervisory direction, in conformance with the 'Minimum Standards for Land Surveying in New Mexico', and that same is true and correct to the best of my knowledge.
