



ANNEXATION PLAT

DESCRIPTION - ANNEXATION TRACT

A TRACT OF LAND IN SECTION 10, T17S, R9E, NMPM, DESCRIBED BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT THE CENTER ONE QUARTER CORNER OF SAID SECTION 10 AND GOING N89°47'31"E ALONG THE EAST-WEST CENTERLINE OF SAID SECTION 10 A DISTANCE OF 1338.74 FEET TO THE PRESENT ALAMOGORDO CITY LIMITS, THENCE S00°07'58"E ALONG SAID CITY LIMITS A DISTANCE OF 250.00 FEET, THENCE S89°47'31"W A DISTANCE OF 1603.07 FEET, THENCE ALONG THE ARC OF A CURVE TO THE RIGHT WHOSE CENTRAL ANGLE IS 27°41'13" AND WHOSE RADIUS IS 1125.00 FEET AN ARC DISTANCE OF 543.63 FEET, THENCE N13°51'08"E A DISTANCE OF 322.26 FEET, THENCE N49°28'46"W A DISTANCE OF 273.88 FEET, THENCE N50°12'21"E A DISTANCE OF 129.33 FEET, THENCE ALONG THE ARC OF A CURVE TO THE LEFT WHOSE CENTRAL ANGLE IS 18°19'27" AND WHOSE RADIUS IS 1200.00 FEET AN ARC DISTANCE OF 383.78 FEET, THENCE N31°53'04"E A DISTANCE OF 233.32 FEET, THENCE N64°29'00"E A DISTANCE OF 490.00 FEET, THENCE S00°08'08"E A DISTANCE OF 1147.03 FEET TO THE SAID PLACE OF BEGINNING, AND CONTAINING 27.684 ACRES, MORE OR LESS.
