




STARTING AT THE NORTHWEST CORNER OF SAID NORTHEAST QUARTER OF SECTION 33 AND GOING S89° 53' 39" E A DISTANCE OF 197.57 FEET TO THE INTERSECTION OF THE SOUTH RIGHT-OF-WAY LINE OF NEW MEXICO STATE ROAD NO. 545 AND THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE N81° 59' 08" E ALONG SAID SOUTH RIGHT-OF-WAY LINE A DISTANCE OF 725.51 FEET; THENCE S19° 41' 01" E A DISTANCE OF 1304.83 FEET TO THE SOUTH LINE OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 33; THENCE S89° 54' 26" W ALONG LAST SAID SOUTH LINE A DISTANCE OF 362.54 FEET; THENCE S89° 53' 39" W CONTINUING ALONG LAST SAID SOUTH LINE A DISTANCE OF 786.19 FEET TO THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 33; THENCE N00° 28' 00" W ALONG THE WEST LINE OF SAID NORTHEAST QUARTER A DISTANCE OF 1129.51 FEET TO THE PLACE OF BEGINNING AND CONTAINING 25.533 ACRES, MORE OR LESS.
