



CERTIFICATE OF SURVEY

DESCRIPTION: TRACT 7

A TRACT OF LAND IN THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER (NE1/4NW1/4) AND THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER (NW1/4NE1/4) OF SECTION 5, T16S., R13E., N.M.P.M. AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

STARTING AT THE SOUTHWEST CORNER OF LOT ELEVEN (11), SAID SECTION 5, AND GOING S74°15'19"E A DISTANCE OF 1259.39 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE N87°18'00"E A DISTANCE OF 274.16 FEET; THENCE S22°51'53"W A DISTANCE OF 540.73 FEET; THENCE S83°38'35"W A DISTANCE OF 224.64 FEET; THENCE N17°21'41"E A DISTANCE OF 534.55 FEET TO THE PLACE OF BEGINNING AND CONTAINING 2.797 ACRES, MORE OR LESS.

SUBJECT TO A TWENTY-FIVE (25) FOOT WIDE ACCESS EASEMENT EXTENDING ACROSS THIS TRACT PARALLEL WITH AND ADJACENT TO THE SOUTH LINE OF THIS TRACT.

DESCRIPTION: TRACT 8

A TRACT OF LAND IN THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER (NE1/4NW1/4) AND THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER (NW1/4NE1/4) OF SECTION 5, T16S., R13E., N.M.P.M. AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

STARTING AT THE SOUTHWEST CORNER OF LOT ELEVEN (11), SAID SECTION 5, AND GOING S77°31'21"E A DISTANCE OF 1521.94 FEET TO THE PLACE OF BEGINNING OF THE TRACT OF LAND HEREIN DESCRIBED; THENCE N87°22'42"E A DISTANCE OF 119.91 FEET; THENCE S00°12'06"W A DISTANCE OF 677.35 FEET; THENCE N62°04'15"W A DISTANCE OF 370.68 FEET; THENCE N22°51'53"E A DISTANCE OF 540.73 FEET TO THE PLACE OF BEGINNING AND CONTAINING 3.222 ACRES, MORE OR LESS.
