My name is Kenneth Casares Owens and I manage the New Mexico Attorney General's **Keep Your Home New Mexico Program**. I am writing to your organization to share a valuable resource for helping New Mexico homeowners who are struggling with their mortgage or facing foreclosure.

I am also writing to ask for your assistance with sharing this resource with New Mexicans who visit your office and website.

With mortgage delinquencies and foreclosures, reaching almost 1 in 10 homes in New Mexico, the Attorney General's office has launched the "Keep Your Home New Mexico" program. The program is designed to provide direct foreclosure prevention services to homeowners who are struggling with their mortgage loan. This unprecedented effort is a statewide collaboration between the Attorney General's office and several non-profit agencies that provide direct housing counseling and foreclosure legal defense services to struggling homeowners.
